Entry Fee (after Nov 30 & on the day of the race): \$33 Adults;

- T-Shirts:** Free t-shirts for all pre-registered runners. Guaranteed to get your size if you register by Nov 8.
- Course:** The race begins and ends at the Boys and Girls Club of Brevard on Gallimore Road--just outside of downtown Brevard. The course is mostly flat with a few short hills. Runners will enjoy a 1 mile trek through a neighborhood and then 2 miles of beautiful countryside and end with a nice flat run to the finish. This race is the kickoff event for the Brevard Twilight Festival, complete with Christmas parade. Bring the whole family for a day of fun.
- Awards:** Awards are given for the top two male and female overall finishers and for all children 12 and under. Medals will be given to the top 3 male and female finishers in each of the following categories: 5-12, 13-14, 15-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-74, 75-79, 80 and over.

# REINDEER RUN WAIVER

## AGREEMENT TO PARTICIPATE RELEASE WAIVER

In consideration of being allowed to participate in any way in The Center for Women related events and activities; the undersigned acknowledges, appreciates and agrees that:

1. The risk of injury from the activities involved in the Reindeer Run is significant, including the potential for permanent paralysis and death; and,
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releasees or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my participation, I will remove myself from participation and bring such to the attention of the nearest The Center for Women representative; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless The Center for Women, their officers, officials, agents and/or employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event.
5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless the State of North Carolina, the North Carolina Department of Transportation, Transylvania County, town of Brevard, if applicable, their officers, officials, agents and/or employees, volunteers,
6. I grant to The Center for Women my permission to use without charge any and all photographs, video reproductions or other like kinds of image productions taken during the event.
